#### B. Report of Fair Housing Services – Quarterly Report

Benson reviewed that in June 2017, the RDA approved a Subrecipient Agreement with the Metropolitan Milwaukee Fair Housing Council (MMFHC) to provide Fair Housing Services. As an Entitlement community within the CDBG Program, the City is required to undertake certain efforts to promote, or affirmatively further, fair housing. Fair housing services provided by the Fair Housing Council include enforcement; education and outreach; fair lending and research/analysis of affordable housing opportunities. Benson reviewed MMFHC's report for the First and Second Quarter ending on January 31, 2019.

#### C. Resolution No. - 19-03 A Resolution Approving the Updated Citizen Participation Plan

Benson reviewed that US Department of Housing and Urban Development (HUD) requires all CDBG entitlement grantees to have a Citizen Participation Plan in place and to review and update it periodically. She stated that the current Plan meets the basic intent of the CDBG Program; however, there is language that should be updated.

Benson indicated that the revised Plan includes language regarding additional detail on changes that require a public hearing and the complaint process.

Ewald made a motion to approve Resolution No. 19-03; seconded by Miller. Motion Carried.

#### D. Discussion Regarding Water Damage

Benson reviewed the effects of the water damage to homes in Fond du Lac as a result of the flooding that occurred on March 14, 2019. Benson stated that most of the damage that occurred was in the basements of the homes which resulted in damage or loss of furnaces and hot water heaters. Benson is requesting that if homeowners seek assistance to repair or replace these items, that staff be allowed to process the loans once all their verifications have been obtained and that the Redevelopment Authority (RDA) will approve the loans at the following RDA meeting. Benson further stated that the homeowners would need to meet program qualifications to obtain a loan and that the funding would be offered first to existing clients and then to any new clients.

It was the consensus of the RDA to approve staff moving forward with the loans as needed allowing for the approval from the RDA at their next regular scheduled meeting.
