_____ is granted a license by the Director of Public Works of the City of Fond du Lac, Wisconsin to construct and reconstruct sidewalks in said city, and if he, in that case, shall for a term of two (2) years from the date of the issuance of said license indemnify and save harmless the City of Fond du Lac from all unfaithful, imperfect or inadequate work done by him under authority of the said license, and will replace and restore any imperfect work which may be discovered within a period of two (2) years from the time of its completion by him, and will abide by the rules, regulations and specifications which are or may hereafter be adopted by the Council and obey all ordinances of said city in relation to said work or sidewalk construction, and then this obligation shall be void and of no effect; otherwise to remain in full force and virtue.

IT IS UNDERSTOOD AND AGREED that this bond is also given for the benefit of all persons for whom said licensee shall perform work under his license and may be enforced by them or any of them in an action in their own name.
