

## ELEVATION CERTIFICATES

The Elevation Certificate is an administrative tool of the National Flood Insurance Program (NFIP). As part of the agreement for making flood insurance available in a community, the NFIP requires the community to adopt floodplain management regulations for reducing flood losses. An Elevation Certificate provides a way for a community to document compliance with the floodplain management ordinance.

An Elevation Certificate is used to provide information necessary to ensure compliance with the floodplain management ordinance, to determine the proper flood insurance premium rate, and to support a request for a Letter of Map Amendment (LOMA) or a Letter of Map Revision based on fill (LOMR-F). An elevation certificate is prepared by a professional land surveyor or engineer.

Elevation certificates that have been submitted to the City of Fond du Lac after 4/17/2012 for properties located in a special flood hazard area are a matter of public record and are on file in the Community Development Department and in the Building Inspection Division at 160 South Macy Street.
