City of Fond du Lac - Weekly Construction Update

The City of Fond du Lac is providing a weekly update on construction projects located within the corporate boundary. The Weekly Construction Updates and Construction Map are posted on the City's Website at www.fdl.wi.gov.

County Road V from Pioneer Road to Fond du Lac Avenue

Pioneer Road from Sherwood Boulevard to Wedgewood Road

Schedule: April 2019 through October 2019

Description of work: The project includes reconstruction of the water main and services and partnership with Fond du Lac County for new storm sewer, street, pedestrian trail, and lighting.

May 20th to May 24th: The contractor will be completing the installation of the water main on Pioneer Road west and east of County Road V.

Traffic impacts: County Road V from Fond du Lac Avenue and Pioneer Road is closed to through traffic. Additionally, Pioneer Road from Sherwood Blvd to Wedgewood Lane is closed to through traffic. Residents, business owners, and customers may access properties past "ROAD CLOSED – LOCAL TRAFFIC ONLY" signs.

Project Detour: North on Fond du Lac Avenue to South on Martin Avenue to west on Pioneer Road.

East Cotton Street from North Park Avenue to McKinley Street

Schedule: May 2019 through September 2019

Description: The project includes reconstruction of the sanitary sewer, water main, storm sewer, street, and lighting.

May 20th to May 24th: The utility contractor will begin installing sanitary sewer at McKinley Street, working west.

Traffic Impacts: East Cotton Street is closed to through traffic. Residents, business owners, and customers may access properties past "ROAD CLOSED – LOCAL TRAFFIC ONLY" signs. It is illegal to drive past a "ROAD CLOSED" sign or to move any construction barricades. Parking is not permitted on the street within the construction zone during working hours.

McKinley Street from Rose Avenue to Stow Street

Schedule: May 2019 through September 2019

Description: The project includes reconstruction of the sanitary sewer, water main, storm sewer, street, and lighting.

May 20th to May 24th: The utility contractor will be installing sanitary and water laterals and storm sewer north of Arndt Street.

Traffic Impacts: McKinley Street is closed to through traffic. Residents, business owners, and customers may access properties past "ROAD CLOSED – LOCAL TRAFFIC ONLY" signs. It is illegal to drive past a "ROAD CLOSED" sign or to move any construction barricades. Parking is not permitted on the street within the construction zone during working hours.

Stow Street from McKinley Street to Roosevelt Street

Schedule: May 2019 through September 2019

Description: The project includes reconstruction of the sanitary sewer, water main, storm sewer, street, and lighting.

May 20th to May 24th: The utility contractor will be installing sanitary and water laterals and storm sewer.

Traffic Impacts: Stow Street is closed to through traffic. Residents, business owners, and customers may access properties past "ROAD CLOSED – LOCAL TRAFFIC ONLY" signs. It is illegal to drive past a "ROAD CLOSED" sign or

to move any construction barricades. Parking is not permitted on the street within the construction zone during working hours.

Roosevelt Street from Rose Avenue to Arndt Street

Schedule: May 2019 through July 2019

Description: The project includes reconstruction of the sanitary sewer, water main, storm sewer, street, and lighting.

May 20th to May 24th: The utility contractor will be installing water laterals and extending sanitary laterals.

Traffic Impacts: Roosevelt Street is closed to through traffic. Residents, business owners, and customers may access properties past "ROAD CLOSED – LOCAL TRAFFIC ONLY" signs. It is illegal to drive past a "ROAD CLOSED" sign or to move any construction barricades. Parking is not permitted on the street within the construction zone during working hours.

Marquette Street from Arndt Street to McWilliams Street

Schedule: July 2019 through October 2019

Description: The project includes reconstruction of the sanitary sewer, water main, storm sewer, street, and lighting.

May 20th to May 24th: No work at this time.

Traffic Impacts: Marquette Street remains open to traffic.

Grove Street from Superior Street to South Military Road

Schedule: April 2019 to June 2019

Description: The project includes reconstruction of the sanitary sewer, water main, storm sewer, street, and lighting.

May 20th to May 24th: The contractor will be removing pavement, driveway approaches, sidewalk, excavating the roadway, and place gravel base.

Traffic Impacts: Grove Street is closed to through traffic. Residents, business owners, and customers may access properties past "ROAD CLOSED – LOCAL TRAFFIC ONLY" signs. It is illegal to drive past a "ROAD CLOSED" sign or to move any construction barricades. Parking is not permitted on the street within the construction zone during working hours.

Intersection of Trowbridge Drive and Willow Lawn Road

Schedule: April 2019 to June 2019

Description: The project includes reconstruction of the sanitary, water extension, storm sewer, street, and lighting.

May 20th to May 24th: The grading contractor will be removing pavement, excavating the roadway, and place gravel base early in the week. Paving and restoration contractors will follow with asphalt and topsoil and seed.

Traffic Impacts: Intersection of Trowbridge Drive and Willow Lawn Road is closed to through traffic. It is illegal to drive past a "ROAD CLOSED" sign or to move any construction barricades. Parking is not permitted on the street within the construction zone during working hours.

Tompkins Street from Superior Street to Termini

Schedule: April 2019 to June 2019

Description: The project includes reconstruction of the sanitary sewer, water main, storm sewer, street, and lighting.

May 20th to May 24th: The grading contractor completed the grading of the road and prepared the gravel base for concrete curb and gutter. The electrical and curb work is scheduled to be completed by weeks end.

Traffic Impacts: Tompkins Street from the railroad tracks to Superior Street is closed to through traffic. Residents may access properties past “ROAD CLOSED – LOCAL TRAFFIC ONLY” signs. It is illegal to drive past a “ROAD CLOSED” sign or to move any construction barricades. Parking is not permitted on the street within the construction zone during working hours.

Hickory Street Bridge over West Branch of Fond du Lac River

Schedule: May 2019 through June 2019

Description: The bridge deck will be milled and a new overlay installed which requires the closure of the bridge to vehicle and pedestrian travel.

May 20th to May 24th: The contractor completed the bridge surface repairs and milling. They will continue to prepare the deck for placing the concrete overlay by mid-week. The deck will need a 7 day cure time before paving the approaches and reopening to traffic.

Traffic Impacts: Hickory Street Bridge will be closed to traffic and pedestrian access. Follow the signed detour which is South Bound (SB) – Western Ave. to N. Brook Street to S. Military and North Bound (NB) is the reverse order of SB.

East Second Street Bridge over DeNeveu Creek

Schedule: May 2019 through June 2019

Description: The contractor completed the surface repairs on the bridge deck and sidewalk. An epoxy overlay will be placed which is scheduled to begin mid-June. When the epoxy overlay starts the bridge will be closed for a few weeks. This will restrict vehicle and pedestrian access across the bridge.

May 20th to May 24th: The contractor completed the surface repair work and will begin the epoxy overlay in mid-June.

Traffic Impacts: E. Second Street Bridge is currently open to traffic and will remain open until the epoxy overlay work begins mid-June then it will be closed to both vehicle and pedestrian access for several weeks.

Johnson Street, STH 23 from Main Street to Peters Avenue

Schedule: May 20th through June 7th

Description: The Department of Public Works crews will be removing the brick pavers located in the crosswalks on Johnson Street west of Main Street starting the week of May 20th. City crews will also be performing other maintenance in the work zones including work along with a contractor performing repairs on the Johnson Street Bridge.

May 20th to May 24th: Crews will start with the removals of the cross walk on the west side of Main Street working west. The removal of the bricks will be followed by placing new colored, stamped, concrete. Although the removal and placement of the new concrete will progress timely, the newly placed concrete needs several days to cure to reach max strength.

Traffic Impacts: Starting early on Monday, May 20th, Johnson Street between Hickory Street and Main Street and the Johnson Street Bridge will be **closed** to through traffic. Traffic at the cross street intersections for north and south streets will be maintained. Additionally traffic lane restrictions will be in place on Johnson Street from Peters Avenue to Hickory Street. During this phase of the project traffic control will be set up to allow two way traffic on Johnson. The lane restrictions between Peters Avenue and Hickory Street are planned to be in place until June 7th. Pedestrian access will be allow within 24 hours of pouring the crosswalks. Motorists can follow the signed detour in place Hwy 23, to Hwy 41, to Hwy 151.
