INCOME PROTECTION	1 ST FULL MONTH OF EMPLOYMENT	ELIGIBLE TO EARN ONE DAY OF SICK LEAVE PER MONTH (PRO-RATED) TO MAX OF 135 DAYS.
RETIREMENT	DATE OF HIRE	ELIGIBLE TO PARTICIPATE IN WISCONSIN RETIREMENT SYSTEM (WRS) IF WORKING AT LEAST 1200 HOURS; EMPLOYEE & CITY EACH CONTRIBUTE; ELIGIBLE TO PARTICIPATE IN ICMA 457 PLAN AND ROTH IRA; EMPLOYEE CONTRIBUTIONS ONLY.
