SEX OFFENDER INFORMATION BULLETIN

The Fond du Lac Police Department is releasing the following information pursuant to Wisconsin State Statute 301.45 and 301.46 (Act 440), which authorizes law enforcement agencies to inform the public of a sex offenders release when, at the discretion of the agency, the release of information will enhance public safety and protection.

The individual who appears on this notification has been convicted of a sex offense that requires registration with the local law enforcement agencies. Further, his/her previous criminal history places the offender in a classification level which reflects the potential to re-offend.

This sex offender has served the sentence imposed on him/her by the courts and has advised officials that he/she will be living in the location below. THIS PERSON IS NOT WANTED BY THE POLICE AT THIS TIME. THIS NOTIFICATION IS NOT INTENDED TO INCREASE FEAR; RATHER, IT IS OUR BELIEF THAT AN INFORMED PUBLIC IS A SAFER PUBLIC.

Sex offenders have always lived in our communities but it was not until passage of Act 440 (which mandates sex offender registration) that law enforcement even knew where they were living. In many cases, law enforcement is now able to share that information with you. Citizen abuse of this information to threaten, intimidate, or harass registered sex offenders will not be tolerated. Further, such abuse could potentially end law enforcement's ability to do community notification. We believe the only person who wins if community notification ends is the sex offender, since sex offenders derive their power through secrecy.

The Fond du Lac Police Department is available to help you set up Neighborhood Watches and to provide you with useful information on personal safety. The Fond du Lac Police Department has been notified of a change of address for **Darin S. Klumpyan**. **Klumpyan** was previously released from prison on October 2, 2011, after serving 7 years for 2nd Degree Sexual Assault of a Child and three counts of Lewd and Lascivious Behavior. Klumpyan was convicted of sexually assaulting a 15-year-old female acquaintance through coercion. In addition, he was convicted for exposing himself to both adult and juvenile victims. Klumpyan also has convictions for looking into adult females windows at night. Klumpyan was previously residing in the 100 block of W 2nd Street.

Special conditions of Darin S. Klumpyan's supervised release:

- 1) Darin Klumpyan is no longer on any type of probation, parole or extended supervision.
- 2) Darin Klumpyan is required to comply with the Sex Offender Registry for Life.

Klumpyan is currently residing at 685 Morris St.
