## SEX OFFENDER INFORMATION BULLETIN

The Fond du Lac Police Department is releasing the following information pursuant to Wisconsin State Statute 301.45 and 301.46 (Act 440), which authorizes law enforcement agencies to inform the public of a sex offenders release when, at the discretion of the agency, the release of information will enhance public safety and protection.

The individual who appears on this notification has been convicted of a sex offense that requires registration with the local law enforcement agencies. Further, his/her previous criminal history places the offender in a classification level which reflects the potential to re-offend.

This sex offender has served the sentence imposed on him/her by the courts and has advised officials that he/she will be living in the location below. THIS PERSON IS NOT WANTED BY THE POLICE AT THIS TIME. THIS NOTIFICATION IS NOT INTENDED TO INCREASE FEAR; RATHER, IT IS OUR BELIEF THAT AN INFORMED PUBLIC IS A SAFER PUBLIC.

Sex offenders have always lived in our communities but it was not until passage of Act 440 (which mandates sex offender registration) that law enforcement even knew where they were living. In many cases, law enforcement is now able to share that information with you. Citizen abuse of this information to threaten, intimidate, or harass registered sex offenders will not be tolerated. Further, such abuse could potentially end law enforcement's ability to do community notification. We believe the only person who wins if community notification ends is the sex offender, since sex offenders derive their power through secrecy.

The Fond du Lac Police Department is available to help you set up Neighborhood Watches and to provide you with useful information on personal safety. The Fond du Lac Police Department has been notified that **Dominic Carmona** is being released from prison and back into the community. **Carmona** is being released from prison after serving over 3 years of confinement for a conviction of Sexual Assault of a Student by School Staff and Child Enticement-Sexual Contact in 2015. Carmona was convicted of sexually assaulting a female student at the school where he was employed as a Special Education teacher. Carmona engaged in sexual chatting (via e-mail), sending photos of himself in his underwear to the victim and purchasing gifts such as underwear for the victim. Assaultive behavior occurred on multiple occasions and involved kissing and sexual touching.

**Carmona is on extended supervision until February 2024. Special conditions of Dominic C Carmona's supervised release:**

- 1) No contact with victim, no unsupervised contact with minors, no presence in taverns, bars, or liquor stores, and no use of alcohol or illegal drugs.
- 2) Comply with all rules of high risk sex offender supervision and cooperate with lifetime GPS monitoring.
- 3) Face-to-face contact with law enforcement as required, lifetime registration with Wisconsin Sex Offender Registration Program.

**Dominic C Carmona** will be temporarily living at **457 Thomas St.** in the City of Fond du Lac upon his release on or about February 5, 2019.
