SEX OFFENDER INFORMATION BULLETIN

The Fond du Lac Police Department is releasing the following information pursuant to Wisconsin State Statute 301.45 and 301.46 (Act 440), which authorizes law enforcement agencies to inform the public of a sex offender's release when, at the discretion of the agency, the release of information will enhance public safety and protection.

The individual who appears on this notification has been convicted of a sex offense that requires registration with the local law enforcement agencies. Further, his previous criminal history places the offender in a classification level which reflects the potential to re-offend.

This sex offender has served the sentence imposed on him by the courts. THIS PERSON IS NOT WANTED BY THE POLICE AT THIS TIME. THIS NOTIFICATION IS NOT INTENDED TO INCREASE FEAR; RATHER, IT IS OUR BELIEF THAT AN INFORMED PUBLIC IS A SAFER PUBLIC.

Sex offenders have always lived in our communities but it was not until passage of Act 440 (which mandates sex offender registration) that law enforcement even knew where they were living. In many cases, law enforcement is now able to share that information with you. Citizen abuse of this information to threaten, intimidate, or harass registered sex offenders will not be tolerated. Further, such abuse could potentially end law enforcement's ability to do community notification. We believe the only person who wins if community notification ends is the sex offender, since sex offenders derive their power through secrecy.

The Fond du Lac Police Department is available to help you set up Neighborhood Watches and to provide you with useful information on personal safety. The Fond du Lac Police Department has been notified that **Issac Johnson**, is being released back into the Fond du Lac Community after serving prison time for a conviction of Possession of Drug Paraphernalia in 2018. Johnson was previously convicted in 1997 for 2-counts of Second-Degree Sexual Assault of a Child, and in 1995 for Sex with a Child Age 16 Years or Older. Johnson's victims included female acquaintances.

Isaac A Johnson is on extended supervision until June 2021. Special conditions of Isaac Johnson's supervised release:

- 1) No contact with victim, no unsupervised contact with minors, no presence in taverns, bars, or liquor stores, and no use of alcohol or illegal drugs.
- 2) Comply with all rules of high risk sex offender supervision and cooperate with lifetime GPS monitoring.
- 3) Face-to-face contact with law enforcement as required, lifetime registration with Wisconsin Sex Offender Registration Program.

Isaac Johnson will be living at **457 Thomas Street** in the City of Fond du Lac on or about April 16, 2019.
