SEX OFFENDER INFORMATION BULLETIN

The Fond du Lac Police Department is releasing the following information pursuant to Wisconsin State Statute 301.45 and 301.46 (Act 440), which authorizes law enforcement agencies to inform the public of a sex offenders release when, at the discretion of the agency, the release of information will enhance public safety and protection.

The individual who appears on this notification has been convicted of a sex offense that requires registration with the local law enforcement agencies. Further, his/her previous criminal history places the offender in a classification level which reflects the potential to re-offend.

This sex offender has served the sentence imposed on him/her by the courts and has advised officials that he/she will be living in the location below. THIS PERSON IS NOT WANTED BY THE POLICE AT THIS TIME. THIS NOTIFICATION IS NOT INTENDED TO INCREASE FEAR; RATHER, IT IS OUR BELIEF THAT AN INFORMED PUBLIC IS A SAFER PUBLIC.

Sex offenders have always lived in our communities but it was not until passage of Act 440 (which mandates sex offender registration) that law enforcement even knew where they were living. In many cases, law enforcement is now able to share that information with you. Citizen abuse of this information to threaten, intimidate, or harass registered sex offenders will not be tolerated. Further, such abuse could potentially end law enforcement's ability to do community notification. We believe the only person who wins if community notification ends is the sex offender, since sex offenders derive their power through secrecy.

The Fond du Lac Police Department is available to help you set up Neighborhood Watches and to provide you with useful information on personal safety. The Fond du Lac Police Department has been notified that **Robert W Krenn**, is being released back into the Fond du Lac Community after serving 23-years prison time for 3 counts of 1st Degree Sexual Assault of a Child and 1 count of Repeated Acts of Sexual Assault of a Child. Krenn was convicted in 1995 of sexually assaulting a pre-teen and teenage female relatives.

Special conditions of Robert W Krenn's supervised release:

- 1) No contact with victims, no unsupervised contact with minors, no presence in taverns, bars, or liquor stores, and no use of alcohol or illegal drugs.
- 2) Comply with all rules of high risk sex offender supervision, and cooperate with electronic monitoring.
- 3) Face-to-face contact with law enforcement as required, lifetime registration and GPS with Wisconsin Sex Offender Registration Program.

Robert W Krenn will be residing at **231 W Follett Street** in the City of Fond du Lac. Krenn will be temporarily staying at 131 E 2nd Street upon his release on or about September 24, 2019 for a 1-2 week period before moving to Follett St. Krenn will be required to wear a GPS monitoring bracelet for life.
