

The Situation

- 1. Lead presents a significant and permanent health hazard
- 2. Lead can leach from older service lines and interior fixtures into drinking water

 Recent studies shown that partial replacement of lead service lines (LSLs) significantly elevates lead exposure for a number of years.

The Situation (con't)

- 4. Our lead program is currently in compliance, so changes are voluntary
- The EPA is planning to issue a rule in 2017 that would prohibit partial LSL replacement, to be implemented as soon as 2019
- FdL rec'd a \$300k Safe Drinking Water Loan (SDWL) for 2017, and qualifies for principal forgiveness.
- Have been invited to apply for '18, but competition is tougher, and our ranking isn't high



Do nothing

- Simplest, and perfectly legal
- But doesn't address risk to residents
- ... Doesn't take advantage of \$300k "grant"
- Mandatory Private LSL Replacement
- Voluntary Private LSL Replacement

The Program Big Picture

- We recommend *mandating* full LSL replacement when appropriate
 - Would be done by ordinance
 - Would apply when the public LSL replaced through annual street project or because of water leak
 - SDWL could be used to provide City cost share, assess owner's share over time
 - Similar to Milwaukee, Madison, Kewaunee approaches

The Program Annual Project Process

- Notify owners 45 days prior to project starting
- Do records show water service is lead?
- Allow owners to verify mat'l in basement
- Allow owners to join City contract for private LSL replacement
- City inspectors verify mat'l at property line as project underway; updates owner
- Private LSL replacement in conjunction w/ public work (but separate contractor)

The Program The Timing

- If Council supports an ordinance, now is the best time...
 - Private LSL replacement should be done at same time as public (separate contract)
 - Street contract start ~ mid-April
 - LSL contract start ~ May 1st
 - Assmn't public hearing/final resolution Apr 12th
 - Bid opening Mar 28th
 - Preliminary assmn't to Council Mar 8th, to Plan Commission Feb 13th

The Program Water Break Process

- If a water break is found anywhere on a water service...
- Confirm mat'l. If contains lead...
- Notify owner of req't to replace; invite to participate in assessment and cost share program, if available
- Complete entire LSL replacement together, public side by crew, private side by contractor

The Program The Money

- Statewide cost estimates = \$3,000 average for private LSL replacement
- \$300k available for City cost share
 - 152 homes ('17 project), 66 homes ('18 project),
 ~20 emergency or voluntary LSL repairs = 238 homes
 - City would establish maximum amount of subsidy, based on loan/grant funding and the number of participants.
 - In this scenario, \$1,260 City share (reimbursed by SDWL), \$1,740 owner share (assessed, has up to five years to pay back, General Fund balance initial source)

The Program Misc Notes

- Only homes (1-4 units) that use City contract eligible for cost-share program
- Homes that have had the public LSL replaced in the past may elect to participate for private LSL.
- 6-month extension possible for extenuating circumstances; owner would need to purchase filter and to agree to take other steps to reduce exposure.
- If owner doesn't agree or respond, citations could start as soon as public LSL is replaced
- No schools have lead services; two daycares might, and may elect to participate in the program.
- Most commercial properties do not have lead services, and not eligible for SDWL funding.

The Alternative

- Valid reasons to not mandate private LSL replacement
 - Hardship on affected residents
 - Fund balance (i.e. all taxpayers) fronting money for private share
 - Expectations for a City cost share in the future (even without grants or loans)
 - Enforcement challenges
 - Future changes or funding might make this simpler or less expensive—wait and see?

The Alternative (con't)

- Could make this a voluntary program
 - Educate/encourage homes in '17 & '18 street projects to replace private LSL when public replaced.
 - Notify homes with private LSL (w/ public side replaced already) about cost share program
 - Invite homes with a break in an LSL to participate, have the full LSL replaced.
 - Use Water Fund to purchase filters for homes with known LSLs (regardless of ordinance).
 - Still pursue ordinance, prepare for likely EPA rule change.
 - Similar to Eau Claire, Sheboygan programs
- Concern that voluntary program could be grossly underused, SDWL funding left on the table

Future Considerations

- Monitor other communities' programs and ordinances for good ideas
- Monitor progress w/ EPA rule change and implementation schedule
- See whether administration change may affect this program
- Monitor WDNR changes/adaptation
- Research and apply for future State/ Federal funding to aid our program
